The customer is responsible for specifying fabrics compliant with the following guidelines.

Product Selection Guidance:

Formaldehyde

All of the Davis Furniture products listed above are currently SCS Indoor Advantage Gold certified to meet the formaldehyde emissions requirement. They have been tested in accordance with ANSI/BIFMA standard method M7.1/X7.1-2011 R2016 and ANSI/BIFMA e3-2014e. Certificates are available on the Davis Furniture website.

PFAS

PFAS-free fabrics are available. Some fabrics may contain PFAS, so customers must specify PFAS-free fabrics. Customers are responsible for COM fabric treatments and chemical contents.

Polyvinyl Chloride (PVC's)

Not all Davis Furniture products are 100% PVC free. Some non-work surface edges may contain PVC in an amount less than 1% of the total product weight.¹ Non-PVC edge banding is available on most laminate work surfaces. Veneered work surfaces are PVC free. Some fabrics may contain PVC's, so customers must specify PVC-free fabrics. Customers are responsible for COM fabric treatments and chemical contents.

Antimicrobials

Davis Furniture does not add any antimicrobial chemicals to any of our products. Antimicrobial-free fabrics are available. Some fabrics may contain antimicrobial chemicals, so customers must specify antimicrobial-free fabrics. Customers are responsible for the COM fabric treatments and chemical contents.

Flame Retardants

All standard Davis Furniture products are available with flame retardant free materials unless specifically ordered to meet TB133. Some fabrics may contain flame retardants, so customers must specify flame retardant free fabrics. Customers are responsible for the COM fabric treatments and chemical contents. Any product that includes an electrical device may contain added Flame Retardants.
